#### D. DELEGATIONS & PRESENTATIONS

#### D.1 Grant Thornton-Aaron Kelly

Aaron Kelly from Grant Thornton is here to present the Financial Statements this presentation has been made prior to tonight to the Audit Committee the recommendation to approve the statements will follow the presentation. Aaron reviewed the Independent Auditors Report the option of the audit is that the financial statements present fairly, in all material respects, the financial position of the Town of Digby as of March 31, 2022. Aaron did a review of the Consolidated Statement of Operations the revenue for the year end is \$5,697,890 which is higher that budget and expenses for the year end are \$5,183,801 which is slightly higher than budget this results in a surplus of \$514,089 and brings the accumulated surplus to \$16,956,243. The town is currently in a good financial position.

The Feeding and Wild Birds and Animal by law is coming forward tonight for the Second and Final reading. There are a few folks here tonight who would like to speak on the By law. Davina Halbich Spoke about the issues she has with her neighbour feeding the pigeons and the mess they are making around her property she has asked her neighbour to stop feeding them however she is still feeding the pigeons and at this time Davina is unable to enjoy her outdoor space due to the neighbour feeding the pigeons.

Gary Theriault is also here to speak to the By Law Gary owns the building on Montague Row between Fairway Insurance and the Town of Digby Visitor Information Centre and the man across the street walks over daily to feed the pigeons and birds which results in the pigeons and birds defecating all over his roof, heat pumps. Gary has spoken to the man about the feeding and it's still happening.

Phil Robertson drafted a letter in support of the By law which was read tonight by Gary Theriault the feeding of pigeons and birds on Montague Row at the Visitor Centre is also affecting his residence at 18 Mount Street.

Virginia Olafesen is here tonight to speak against the by law she is very much in favor of continuing to feed the birds and raccoons. Virginia has lots of enjoyment in feeding the animals and she says that the complaint that originated with the neighbour on the feeding of the animals has since been resolved. Virginia spoke about continuing to feed the raccoon if this by law is adopted until hibernation takes place.

Councillor Turnbull spoke about the feeding of raccoons and the disease that they carry according to the Department of Lands of Forrest website. Mayor Cleveland has also done some research into the feeding on racoons and other birds.

Mayor and Council thanked all these folks for their interest in the by law.

#### G. REPORTS

### **G.1** Chief Administrative Officer Report

The CAO reviewed his report with Council. The CAO is reporting that there has been two fire inspections at two commercial properties at 125 First Avenue and 9 Water Street these were a result of complaints received at the Town Hall and also the Deputy Fire Marshall. The Municipality is currently compiling a list of multi-unit residential buildings that require fire inspections. The CAO had a Zoom meeting regarding the Digby District Heating prefeasibility study they will be looking to the Town to provide some data that will be useful to the study. The Emancipation Day

Ceremony was held at the Promenade on August 11, 2022 The CAO expressed his thank you to the Community Development Coordinator and the staff for making the event a success. The Royal Canadian Legion Branch 20 met with the CAO to discuss various topics and one being to have better communication with the Town as well as creating a Veteran Banner Program which will be coming up under New Business. A meeting was held with the CAO and the new VP of resort operations at the Digby Pines in an effort to have more open lines of communication between the Town and the resort in hopes for future collaborations with the Town to create a successful destination. The CAO spoke about the crucial role that the town video surveillance played in the Successful recovery of a backpack/purse left on the promenade. The purse was located on Monday behind the Remax building after a review of the camera footage. The CAO expressed his sincere thank you to the staff for the work involved in locating this purse. The owner of the purse said all items were located in the page including the cash that was inside. The owner was very grateful to the Town, CAO and staff involved in the locating the purse. The slip and fall from July 11, 2022 is now in the hands of the lawyer and insurance company they have taken over the file.

The second matter is the correspondence that we sent to Churchill regarding the presentation to Council for the land interest at the ballfield. Churchill then discussed selling the property at 85 Church Street to the Town for \$235,000 and the trailer from the lot at 74 Sydney Street that the town is in the process of purchasing. The last item referred to is the property at 74 Sydney Street that the town is in the process of purchasing. Council was still not interested in selling the lot of land to Churchill and at this point in time we haven't purchase the lot on Sydney Street.
