Bylaw # 2017-01

A Bylaw to Amend the Bylaw to Repeal Certain Bylaws # 2000-03

BE IT RESOLVED that the Bylaw to Repeal Certain Bylaws # 2000-03 be amended by the addition of the following subsections to Section 1:

- l) Bylaw No. 1974-01 of the Town of Digby which is known as the **Committees Bylaw**.
Note: The Committee Structure of Council is now governed by Council Policy as authorized under Sections 24- 26 of the MGA.
- m) Bylaw No. 1976-02 of the Town of Digby which is known as the **Town Property Bylaw**.
- n) Bylaw No. 1981-01 of the Town of Digby known as the **Tax Exemption - Digby Water Commission**.
- o) Bylaw No. 1981-02 of the Town of Digby known as the **Retention of Records Bylaw**.
Note: Council adopted a records management policy as per Section 34 of the MGA.
- p) Bylaw No. 1983-01 of the Town of Digby known as the **Garbage Bylaw**.
- q) Bylaw No. 2000-08 of the Town of Digby known as the **Town Council Bylaw**.
Note: The Structure of Council is now governed by Council Policy under authority of Section 23 of the MGA.
- r) Bylaw No. 2012-02 of the Town of Digby known as the **Bylaw to Authorize the Voting by Internet and Telephone for the 2012 Municipal Election**.
Note: This bylaw is superseded by Alternative Voting (internet and phone) Bylaw # 2016-01.
