## A BY-LAW TO CLOSE A PORTION OF WEST STREET

- 1. **THAT** the Council do close to public use a portion of the street known as West Street.
- 2. **THAT** the portion of the said street hereby closed to public use pursuant to Section 1 of this By-Law is as follows:

**ALL** that certain piece, parcel or tract of land situated, lying and being in the Town of Digby, County of Digby and Province of Nova Scotia and being a portion of West Street lying between the North Side of the D. A. R. Right-of-way and the South Side of Racquette Road.

**BEING AND INTENDED TO BE** the portion of West Street lying between the North Side of the D. A. R. Right-of-way and the South Side of Racquette Road as shown on Plan of

Survey Entitled Plan Survey Showing Lands of West Street at Digby, Digby County, N. S. Surveys of June & July 1968. Plans drawn June 25-28/69 by Larry Budd from survey of Everett B. Hall Nova Scotia Land Surveyor.

3. **THAT** the portion of West Street as described in Section 2 of this by-law be closed and that all rights of public user heretofore as a street in the lands hereinbefore more particularly described are forever extinguished and the Town may sell and convey the portion so closed.
